**ANNOUNCEMENT: NMC 2023-2025 Officer Election Results– Doña Ana County**

The New Mexico Counties Officer Election took place on Thursday, April 27th, and Friday, April 28th, 2023, at the Doña Ana County Clerk's office. This special election was held to elect the 2023-2025 Doña Ana County Officer and Board Member of New Mexico Counties.

Pursuant to the New Mexico Counties bylaws, the Doña Ana County Clerk and their office are responsible for conducting the New Mexico Counties Officer Election. The County Assessor, County Clerk, County Probate Judge, County Sheriff, County Treasurer, and all five County Commissioners holding office in 2023 were eligible for election and eligible to vote in the special election.

The Bureau of Elections Supervisor, Elections Staff Coordinator, and Chief Deputy Clerk oversaw the election and completed the canvassing of the election on Monday, May 1st at 9:00 am. Seven votes were tallied, and Doña Ana County Clerk Amanda López Askin was elected as the New Mexico Counties Officer for Doña Ana County. Per the bylaws, the New Mexico Counties Executive Director, Joy Esparsen, has been notified. The newly elected representative, Amanda López Askin, shall serve a two-year term beginning at the adjournment of the 2023 NMC June Board of Directors meeting until the adjournment of the 2025 NMC June Annual Conference.


